NEW BUSINESS

Proposal #1: Conduct of Business
Submitted by: Kim Simons, President

Each year the Board must agree on the method to conduct Board Business as provided in the Bylaws which is in compliance with Alabama law related to conducting business without a meeting. In legalese there is a distinction between “meetings” and conducting business. “Meetings” require that all in attendance **MUST** be able to see or hear everyone else so can only be accomplished in-person or by video or telephone conferencing.

Article III, Section 4. Board Business.

The Board of Directors may also conduct business by telephone conference call, mail, and fax provided it does not conflict with any other provision of these Bylaws. All Board members must agree upon the means of communication. Items voted upon by telephone conference call, mail, and fax must be confirmed in writing within seven days.

Since approximately 2002, the Board has “conducted business” by using a Forum or Bulletin Board for discussions with all voting being done by mail or fax. However, the Board has to approve this method of conducting business each year.

Specific Board Action Requested: that the NSDTRC (USA) Officers and Board unanimously agree to continue to use the current on-line Forum for the conduct of business with all voting done by mail or fax during the next year (Nov 1st, 2014 – October 31st, 2015).

Proposal #4: Adding an additional supported entry for western Region 1 (the Finger Lakes Classic) AKC Division 2

Proposal Description/Justification: We have agreed to share with Region 7 (AKC division 2, which includes NY, NJ, and PA) for the special Morris and Essex show. Morris and Essex occurs once every five years. We have already submitted a request for a supported entry at that special show, Marile Waterstraat and Kim Luikert chairs. However, we have just had a very successful supported entry at the Leatherstocking Classic Shows in Syracuse, NY on November 15, with 23 entries, 7 sweeps entries, 4 rally entries, and 1 obedience entry, 5 point majors in both sexes, good food, fun, and earning the Club \$202.65. We feel that it would disadvantage our region's members not to have a supported entry in this area next year, as majors are very difficult to come by in this area. We are asking that an exception be made for 2015, allowing us to have a supported entry in our region, along with the "special" one at the Morris and Essex shows.

Financial Implications: Since this year's supported entry earned the Club \$202.65, I would expect it would gain us about the same amount.

Report of the Legislative Liaison

All has been relatively quiet for the past few months on the legislative front.

Perhaps the biggest event is that a summary judgement was handed down in the Associated Dog Clubs of New York State (ADC of NYS) V. United States Department of Agriculture (USDA) case. This case was filed earlier this year against the USDA by about 42 different dog clubs and individuals. The basis for the suit was that the USDA did not follow proper procedures under the Administrative Procedures Act to create the new rule governing sales of puppies and also that they neglected to take into account the realities of providing the kennel/whelping conditions required of previously unregulated home or hobbyist breeders. The summary judgement was against the plaintiffs. According to the fairly sparse comments available, they are giving some consideration to an appeal. According to other comments I've heard, the basis for any appeal just isn't there. If any one is interested, I can send them the opinion. There's a lot of "legalese" but basically the judge accepted that the government had the right to make the rule and had followed a logical and legitimate process in doing so.

In other news, Julian Prager, an attorney from Pennsylvania, has been hired by USDA/APHIS to help them interpret the rule they released a year ago and to help with any writing of amendments to that rule. Mr. Prager is well-known within the dog world as he is the AKC Delegate for the Central Florida Kennel Club. He has bred and shown Bulldogs for many years. In addition, he is the legal advisor to the National Animal Interest Alliance (NAIA). Mr. Prager has always been helpful to me and sort of guided my discussions with the APHIS representatives concerning breed club rescues, particularly breed clubs which have basically a home based operation such as ours. I really look forward to seeing what he can bring forth from this mess. At first I thought that talking to us would put him in an ethical squeeze but he assured me that since he's not acting in any way as a lawyer for APHIS, we can continue to raise questions and he'll answer them if he can. Apparently his first task will be to write the APHIS response to the Congressional comments contained in the Agriculture Bill passed earlier this year. These comments voiced many of the concerns that hobby breeders had raised when the rule was proposed.

Finally, I am just back from the NAIA Annual Conference ... just back. I'll have a more lengthy report in the next couple of weeks. For now I just want to say that the conference was very good. I would suggest that a member of the Board go to this meeting at least every other year. While I enjoyed the meeting, I think it will help the Board get a broader perspective of just what is going on if someone other than myself attends the next one. Further, a Board member from the locale of the conference will help hold down travel costs in addition to broadening the exposure to the NAIA viewpoint.
