Express or overnight entries, please waive the signature requirement. I will not go to the post office to pick up entries.



### FROM THE FIELD TO THE RING – "BEST WET TOLLER" GUIDELINES

Judging for the Wet Dog contest will begin 30 minutes after Sporting Group has concluded Saturday, June 3rd. This activity is run as a friendly competition for the enjoyment of the owners of field-oriented Nova Scotia Duck Tolling Retrievers who also enjoy conformation. This event is open to all entered and participating in field. Test dogs will also be allowed to participate. The judging will be held near the water as the dog must be wet to at least their shoulders when they arrive in the ring.

There will be one winner at the end of judging: Best Wet Toller. There will also be a Best of Opposite Wet Toller.

Best Wet Toller Award: Decorative wooden duck boat

Location: McHenry Fairgrounds

#### Eligibility:

This event is open to any Nova Scotia Duck Tolling Retriever that meets the following criteria:

- Dog must be entered in the 2017 BYC Field Event. (Scheduled test dogs may also participate). We are also allowing bitches in season to participate, however, owners/handlers need to exercise their judgment to minimize potential incidents
- Tollers eligible to participate in field and conformation (exception: dog can be altered)
- Ungroomed dogs must come to the ring with their handler, field attire preferred but casual dress permitted, (you may use a show lead, English slip lead or regular collar and leash).

#### **Judges Guidelines**

- Dogs will be judged based on the NSDTR breed standard.
- Dogs will proceed to the ring after swimming at least up to shoulders to become wet.
- Classes: 0- under 6 months; 6 months- under 2 years; 2-6 years; 7-up (Veterans). Dogs will proceed first, followed by bitches. Winner of each class will compete for Best Wet Toller.
- Arm bands will be provided and distributed at ring-side.
