Working Certificate Excellent (WCX) for GRs, FCRs, & Poodles Only

Working Certificate Intermediate (WCI) for NSDTRs only*

Entries are limited to a total of 60 dogs with no more than 30 running the WCX/WCI. Preference will be given to GRs currently untitled in the Stake entered. If the limit is not reached, the remaining entry will be filled with untitled dogs of other breeds, then with titled GRs, and then titled dogs of other breeds.*

The **Working Certificate (WC)** is designed to demonstrate the natural ability of the dog to perform normal hunting tasks; marking, memory of falls, intelligence, attention, style, good nose, perseverance, desire and trainability. The test consists of a Land Double and Back-to-Back Water Singles.

The **Working Certificate Excellent (WCX)** is to encourage further development of a retriever's natural hunting and retrieving abilities through additional training. The test consists of a Land Triple, Water Double and an Honor. Mechanical Wingers may be used at this level.

All dogs will run under the GRCA WC/WCX Rules (<http://www.grca.org/events/field/wcwcx.html>)

Non-Golden owners are responsible for handling the necessary paperwork for certificates and approval from the specific parent breed club.

**NSDTR entrants are offered the WC and WCI test only and shall be tested in accordance with the NSDTRC (USA) Field Tests Rules & Regulations dated September 2015.*

On behalf of the membership of the NORCAL Golden Retriever Club, the Committee would like to welcome you to our WC/WCI*/WCX Event. All participants are required to sign a Liability Release Form upon entering the CRTA Denverton Road property. Please check in with the gate attendant upon arrival. **No bitches in season allowed on the test grounds.**

Running order: will be posted on www.norcalgrc.org by April 13, 2019

Stake Scenarios and Test Dog: The **WCX Stake will begin at 8:30am** with the first working dog to run immediately after test dog. **The WC Stake will begin 9:00am** with the first working dog to run immediately after test dog. We ask that you check in with the Stake Marshal and be ready to run when it is your turn. NSDTR shall run last in both stakes.

Refunds: Entry Fees will be fully refunded for all scratches received prior to the closing date. Entry fees will be fully refunded after the closing date for scratches of injured dogs or bitches coming into season prior to the start of the test. There will be a \$25 charge for all other scratches after the closing date.

Prizes: Rosette and a duck band will be awarded to qualifying dogs upon the conclusion of each stake, in the Denverton Property Parking Lot.

Shade: There is no natural shade on the grounds. Please be sure to bring a canopy, umbrella and/or shade cloth and plenty of water. Be ever-vigilant regarding heat exhaustion.

Directions: CRTA Denverton Property, 3836 Denverton Road, Suisun City, CA 94585

From Interstate 80 – Exit Hwy 12 East (towards Rio Vista). Travel ~10 miles to Denverton Road. Turn Right onto Denverton Road, entrance to CRTA property is on the right side.

From Interstate 5 – Exit Hwy 12 West (towards Rio Vista). Travel over the Rio Vista Bridge (towards Fairfield) past the Western Railroad Museum. Turn left onto Denverton Road, entrance to CRTA property is on the right side.

Food: There is no food or water available on the grounds. Restaurants, Fast Food and Groceries are available off Sunset Ave and Hwy 12 in Suisun City.
