Running order will be determined by a random draw at 6:00pm on March 16, 2020 and will be emailed to all handlers.

Ducks will be used in all stakes.

Food and drinks will be provided to the judges and volunteers only.

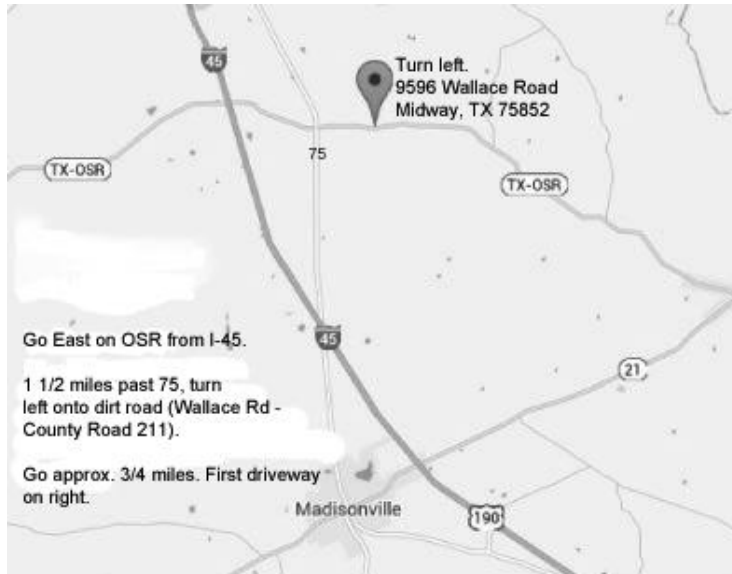
Test Secretary must be informed of move-ups in writing within 30 minutes following the ribbon ceremony.

"A dog must be registered with the American Kennel Club and documentation of AKC registration must be on file with Records to be eligible for Nova Scotia Duck Tolling Retriever Club (USA) titles. For dogs registered with AKC after May 1, 2000 that earn AKC titles and registration information is published in the AKC New Titles of Record Report, no copy of the AKC registration is necessary for club titles to be recorded; for dogs that earn a club field test title prior to any AKC titles, a copy of the AKC registration Certificate must be sent to Records for the title to be recorded"

IMPORTANT INFORMATION

- Please waive the signature requirement on Express or overnight entries. Otherwise, your entry will not be received.
- A dog may be entered in more than one stake or level either or both days at this TX Two-Step. The lower stake will be run prior to the more advanced stake and will have different marks.
- Any dog may compete at the WC or WCI level. Only Tollers with a WCI may compete at the WCX level. (If you enter both the WCI and WCX on both days and your dog does not pass a series of the WCI it will not be allowed to run that WCX series.)
- No bitches in season will be allowed on the grounds. If your entered bitch comes into season or if your dog is injured prior to the test a written note from your veterinarian must be in the hands of the Test Treasurer, Celia Hamilton, 9596 Wallace Rd., Midway, TX 75852, as soon as possible or within seven days of the event for a partial refund.
- There shall be no training of dogs on the grounds of a hunting test, either within 24 hours of the commencement of the event, or at any time during the event.
- Please park in designated areas and avoid going off of the roads into the fields unless there are designated parking areas. We must respect the rights of the landowners who we thank for allowing us the use of their property.
- Remember to bring chairs, water and food for your dog and yourselves, a leash, your whistle, 3 tolling objects, raingear, possibly an umbrella or shade of some sort. **All Toller participants and observers must wear camo or dark clothing.**
- All dogs must be on a leash/lead at all times unless running in a test.
- A restroom will be available for entrants in the barn. Please have respect for privacy and do not expect to use the homes or wander off into other areas of the ranch, as this is a working ranch with families and livestock.
